Introduction to the course

This course provides you with the background and rationale for the implementation of Common Core Standards in a PLC at Work™. It also provides you with tools for unpacking the Common Core Standards in grades k12 and will support you in efforts to design a lesson plan for delivering and measuring those standards within the classroom setting.

14. Apply knowledge of curriculum mapping to implement the Common Core Speaking, Listening and Language Standards (grades K-2).
15. Identify appropriate strategies for assessing Common Core ELA Speaking, Listening and Language Standards (grades K-2).

Opportunities for Assessment & Application

This course will provide you with background on ELA Common Core Standards and help you identify and utilize resources and protocols to facilitate student mastery of Common Core ELA standards. The course will provide you with a framework by which you can unpack ELA Common Core Standards, and then design instruction, assessment criteria and tools (rubrics) that support mastery of standards for *all* students. You will also explore strategies that can be employed to foster successful PLC outcomes when unpacking standards, mapping curriculum, and designing lessons and specific assessment tools. You will have an opportunity to explore Common Core standard types (reading, writing, and speaking and listening for language).

Each module of this online course will contain two assessments:

1. A reflection in which learners will be asked to state their opinions or thoughts on the topics covered in the module, defended by evidence from the content in the module. Reflections are given a pass/fail grade and constructive feedback by the course facilitator.
2. An online quiz containing between 5 and 10 multiple-choice questions on the topics covered in the module. Online quizzes are automatically graded and learners are provided immediate feedback.

In addition to these assessments, the online course contains two “Apply what you’ve Learned Assessments”. As the name indicates, these assessments are written projects requiring research, synthesis and application of the concepts covered in multiple modules. Apply what you’ve Learned Assessments occur at the mid-point and end of the course.

Mid-Term: Apply what you've Learned Assessment

Learners are required to:

- Unpack one of the Common Core ELA Standards.
- List what learners need to know (concepts) and should be able to do (skills). Then identify where the concept and skill falls on the DOK chart and/or Bloom's taxonomy.
- Identify the Big ideas (understandings the learners will remember long after the unit of study).
- Write two Essential Questions (questions that guide instruction and assessment for all lesson activities. Essential questions provide guidance for the big ideas, and should extend the learning beyond basic comprehension).
- List two ideas on how the standard can be accurately assessed.

This assessment is provided a grade by the course facilitator based on a published rubric.

Final: Apply what you've Learned Assessment

Building on the mid-term assignment, learners are required to:

- Create a detailed lesson plan based on 1-2 of the Common Core Standards for Speaking and Listening and for Language. Learners must do the following:
 - Identify the grade level.
 - Identify the subject area.
 - Identify the Standard(s).
 - Identify the anchor standards.
 - Identify Key Vocabulary for unwrapping the standard.
 - Create 1-2 "I Can" learning targets.
 - Describe assessment strategies that will be implemented to monitor and assess learner mastery of the learning targets. Identify specific tools and criteria that will be used to assess standard mastery.
 - Describe the Main Activity that will facilitate active engagement and guided practice in the learning the concept and/or skill. Describe how it facilitates mastery of the standard(s) and learning target.
 - Describe strategies that will be implemented to assist struggling learners in standard mastery.
 - Describe strategies that will be implemented to extend the lesson to provide additional challenges for learners who have already mastered the standard.
 - Identify a strategy your PLC can employ to ensure that all learners achieve standard mastery.
